ABOUT THE POSITION:

Step Up to Justice is dedicated to enhancing its current emergency legal services by introducing proactive upstream outreach and education initiatives. This approach aims to empower community members to prevent future legal disputes and reduce the occurrence of civil legal emergencies.

As part of this strategy, SU2J has launched a comprehensive suite of client education workshops and online modules, presented both live and online in English and Spanish.

To further amplify the influence of SU2J's proactive community education endeavors, the organization is actively recruiting a Community Education Coordinator.

As the Community Education Coordinator, you will have the opportunity to:

- Work with leadership staff and volunteer attorneys to expand workshop content and grow education library products.
- Build and maintain community partnerships to deliver in-person workshops and online modules.
- Design systems to track and evaluate the impact of workshops, online modules, and materials.
- Engage in individual participant follow-up to determine impact of workshops and materials provided.
- Develop marketing strategies to drive community members to workshops and education library resources.

QUALIFICATIONS:

- Demonstrated passion for access to justice issues.
- Strong organizational skills and the ability to manage multiple projects.
- Vision to create new opportunities in civil legal education, training, and technology to improve access to justice.
- Experience working with low-income clients.
- Technology competence, ability to adapt to new technologies.
- Excellent verbal, writing, and organizational skills.
- Marketing experience is a plus.
- Strong personal work ethic.
- Strong interpersonal skills and an ability to work collaboratively with a dynamic team.
- Curious and self-directed with an ability to anticipate what needs to be done.
- Ability to simultaneously manage multiple projects while maintaining a firm grasp of individual project details - getting projects across the finish line. Setting project milestones and managing all elements of the project to meet them.
- Candidates with a four-year undergraduate degree are preferred, but not required.
- Bilingual candidates in Spanish are especially encouraged to apply.

Compensation and Benefits:

Community Education Coordinator is a salaried position. Compensation for this position has been set at \$45,000. The benefits package includes health insurance, health leave, vacation, and personal days.
